May kindly see the property statement online received from Sri Vivek Vikram, Additional Civil Judge (Senior Division)/ Additional Chief Judicial Magistrate, Agra regarding submission of statement for movable and immovable properties acquired/held by him or any member of his family of the financial years 2021-23 (2021-22 & 2022-23) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2021-23 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2021-23 (2021-22 & 2022-23), his gross income from salary is Rs.36,90,117/and total deductions/Savings/investments against, Deposits in Saving Bank Account, NPS, GIS, Income Tax and Insurances are Rs.15,48,646/-. The balance of Rs.64,874/- has increased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.21,41,471/- was therefore available with him to meet out the household expenditure of his family consisting two members in the financial years 2021-23 (2021-22 & 2022-23).

It is to pertinent mention here that officer's wife (Judicial Officer) having annual income was Rs.13,80,000/- for the financial years 2021-22 & 2022-23 respectively.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2019-21 (2019-20 & 2020-21) online against case id-P00022722021 (old case-id: 4402) and same has been processed before Hon'ble Mr. Justice Jayant Banerji, Administrative Judge, Agra for His Lordship's kind perusal and orders .

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2021-23 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. He has submitted movable and immovable property statements for the financial years 2021-23 (2021-22 & 2022-23) vide online dated 23.05.2024. As such, there is delay in submitting the same. In this regard officer verbatim: "I sincerely apologize for the delay in submitting my property statement. I would like to bring to the kind attention of the Hon'ble Court that while I joined the judicial service on 23/07/2015, the induction training took place in February 2017. Consequently, there was a gap in my understanding of the service rules, which primarily contributed to the delay in filing the property statement. Additionally, arranging all the required information took longer than anticipated. I sincerely apologize and assure the Hon'ble Court that such delays will not occur in the future."

May, therefore, if approved, property statements for the financial years 2021-23 (2021-22 & 2022-23) of Sri Vivek Vikram, Additional Civil Judge (Senior Division)/ Additional Chief Judicial Magistrate, Agra be laid before Hon'ble Mr. Justice Jayant Banerji, Administrative Judge, Agra Judgeship for His Lordship's kind perusal and orders?
