May kindly see the property statement submitted online received from Sri Ran Vijay Pratap Singh, Joint Registrar (Judicial) (Computer), Hon'ble High Court of Judicature at Allahabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2017-18 & 2018-19 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 & 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2017-18 & 2018-19, Total income is Rs.31,71,498/- [Gross Income from salary (including allowances & other sources) are Rs.31,65,440/- & returns on mutual fund of Rs.6,058/-] and total deductions/ repayment/ savings/ investment (for both the financial years) against PRAN, GIS, Income Tax, Insurance policies, FD, SIP, installment against Flat, Sukanya Samriddhi Yojna and the balance of his savings bank account(s) is enhanced for Rs.8,373/- this financial year from previous year's balance, total of which is Rs.18,41,725/-. Thus, a sum of Rs.13,29,773/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial years 2016-17 which had already been seen by Hon'ble Mr. Justice B. Amit Sthalekar, the then Administrative Judge, Varanasi, in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial years 2017-18 & 2018-19 vide online dated 05.05.2020. As such, there is delay in submitting the same from the part of the officer for which officer has stated that "at first time, this statement was submitted on 07/04/2020 but inadvertantly with wrong heading i.e. 'statement at the time of joining', however now it is corrected and submitted herewith" mentioned in the remark column no. 9 of movable properties proforma.

Here, it is also submitted that as per resolution dated 12.07.2013 of Hon'ble the Administrative Committee, the matter is likely to be submitted before Hon'ble the Chief Justice, as the officer is presently posted at Hon'ble High Court of Judicature at Allahabad.

May, therefore, if approved, property statements of the financial years 2017-18 & 2018-19 (2017-19) of Sri Ran Vijay Pratap Singh, Joint Registrar (Judicial) (Computer), Hon'ble High Court of Judicature at Allahabad be laid before Hon'ble The Acting Chief Justice for His Lordship's kind perusal and orders?
