May kindly see the online reply dated 22/12/2023 received from Sri Ram Baboo Yadav, Addl. District & Sessions Judge, Etah, in compliance of order of Hon'ble Mr. Justice Nalin Kumar Srivastava, Administrative Judge, Etah Judgeship in the matter of property statements for the financial year 2008-2010 (2008-09 & 2009-10), communicated to the officer.

In this connection, it is submitted that the officer had submitted his movable & immovable property statements for the financial year 2008-2010 (2008-09 & 2009-10) online dated 13.04.2023 on eServicesJO portal, which was put up before Hon'ble the Administrative Judge, Etah through detailed office note dated 03/10/2023, on which His Lordship has been pleased to pass the following order dated 21/12/2023:

"No reason has been assigned by the officer for the delay in submitting property statement for the respective period.

The officer is directed to explain the same."

The order of the Court had been communicated to the officer concerned on 21/12/2023.

In compliance of the Hon'ble Court's order, the Office has submitted his explanation through attached letter dated 22/12/2023, in which officer has stated that:

"..... ,In the light of Hon'ble Court objection dated 21.12.2023, He would like to respectfully inform that at the time of joining judicial service on 15.06.2006, He had firstly submitted the details of his assets in letter no. J.P. 1068/I/Jaunpur dated 23.11.2009 was sent to the Hon'ble High Court. On which objection regarding non-existence of his countersignature was presented by Joint Registrar (M), Hon'ble High Court of Allahabad in letter No.698/IV-3352/Admin (A)/Allahabad dated 13.01.2010.

Again, He sent the details of movable and immovable property for the financial years 2009-10, 2010-11 and 2011-12 to the Hon'ble High Court, Allahabad through letter number 1291/1/Gorakhpur dated 05.11.2018. On which objection related to savings and expenditure in the financial year 2009-10 was presented by the Assistant Registrar (Admin A-IV), Hon'ble High Court of Allahabad in letter No.16129/IV-3352/Admin (A-IV)/Allahabad dated 13.12.2022. The reply to which was sent by his to the Hon'ble High Court through letter number 2093/XI (Civil)/2022/Etah dated 15.12.2022 and revised reply letter number 58/XI (Civil)/2023/Etah dated 04.01.2023. It was directed to submit revised movable and immovable property of the financial years 2006-07, 2007-08, 2008-09 and 2009-10 by the letter No.4321/IV-3352/Admin (A-IV)/Allahabad dated 29.03.2023 of the Registrar General, Hon'ble High Court of Allahabad. In response to which He presented the details of movable and immovable property from the financial year 2006-07 to the financial year 2021-22 through letter number 655/XI (Civil)/2023/Etah dated 11.04.2023. Due to the above reasons, there was delay in submitting the details of movable and immovable property and its resolution.

Sir, if there is any delay, please consider the mistake of the applicant and please review and approve the property details from 2006-07 to the financial year 2021-22. The officer will not make such a mistake."

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2008-2010 (2008-09 & 2009-10) in its next financial year i.e., 2010-11 upto March 2011. He has not stated about the property statement for the year 2008-09, but has stated that he firstly submitted the statement for the year 2009-10 alongwith the statements for the year 2010-11 & 2011-12 in offline mode vide his letter 05.11.2018. But that too was late for the year 2008-2010 (2008-09 & 2009-10). In this regard, officer has attached an apology letter dated 22.12.2023 in compliance the Hon'ble Court's order.

May therefore, if approved, movable & immovable property statement for the financial year 2008-2010 (2008-09 & 2009-10) alongwith the reply/ compliance of Hon'ble Court's order, as desired by the Court in the matter, furnished by Sri Ram Baboo Yadav, Addl. District & Sessions Judge, Etah, be laid before Hon'ble Mr. Justice Nalin Kumar Srivastava, Administrative Judge, Etah Judgeship for His Lordship's kind perusal and orders?
