May kindly see the property statement submitted online from Sri Ashwani Kumar-I, Chief Judicial Magistrate, Varanasi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2021-2023 (2021-22 & 2022-23) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2021-2023 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2021-2023 (2021-22 & 2022-23), Total income from Salary including Leave Encashments and LLM arrears is Rs.41,70,756/- and total deductions/ repayment/ savings/ investment against NPS, GIS, GVR, Mutual Funds, Gold Bonds, Income Tax, PPF and Insurance policies is Rs.25,06,585/- and the balance of his savings bank account(s) is also increased by Rs.2,59,023/- in this financial year from previous year's balance, total of which is Rs.27,65,608/-. Thus, a sum of Rs.14,05,148/- was therefore available with him to meet out the household expenditure of his family consisting two members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statements of the financial years 2019-2021 (2019-20 & 2020-21) online vide Case Id: P00004882021 (Old Case Id : 2525) and the same has been processed before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Varanasi Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2021-2023 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. He has submitted movable and immovable property statements of the financial years 2021-2023 (2021-22 & 2022-23) vide online dated 20.04.2023. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements of the financial years 2021-2023 (2021-22 & 2022-23) of Sri Ashwani Kumar-I, Chief Judicial Magistrate, Varanasi, be laid before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Varanasi Judgeship for His Lordship's kind perusal and orders?
