May kindly see the property statement received online from Sri Satyam Singhal, Nyayadhikari, Gram Nyayalaya, Pindara, Varanasi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2021-23 (2021-22 & 2022-23) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2021-23 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2021-23 (2021-22 & 2022-23), Gross income from salary is Rs.24,76,908/- and total deductions/savings/investment against GIS, NPS, Income Tax, PPF, Mutual fund and the balance of his savings bank account is also enhanced by Rs.4,49,564/- in this financial year from previous year's balance, total of which is Rs.11,52,737/-. Thus, a sum of Rs.13,24,171/- was therefore available with him to meet out the household expenditure of his family consisting two members in both of the financial years. It is pertinent to mention here that Officer's wife is also a Judicial officer having annual income of Rs.10,49,049/- & Rs.13,47,614/- in the financial year 2021-22 & 2022-23 respectively, as mentioned by the Officer.

In this connection, it is submitted that the Officer has submitted his property statement upto the financial year 2019-21 and the same has also been processed online against Case Id : P00055422022 before Hon'ble Mr. Justice Saumitra Dayal Singh, Administrative Judge, Varanasi Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2021-23 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. He has submitted his movable and immovable property statements for the financial years 2021-23 (2021-22 & 2022-23) firstly vide online dated 02.05.2023. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2021-23 (2021-22 & 2022-23) of Sri Satyam Singhal, Nyayadhikari, Gram Nyayalaya, Pindara, Varanasi be laid before Hon'ble Mr. Justice Saumitra Dayal Singh, Administrative Judge, Varanasi Judgeship for His Lordship's kind perusal and orders?
