In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2021-2023 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial year 2021-2023 (2021-22 & 2022-23), the Gross income from salary is Rs.27,42,039/- and total deductions/ repayment/ savings/ investment against GIS, NPS, LIC, PPF, Loan Repayment including downpayments and Income Tax are Rs.17,95,915/-, and the balance of her savings bank account is also increased by Rs.2,22,134/- in this financial year from previous year's balance, total of which is Rs.20,18,049/-. Thus, a sum of Rs.7,23,990/- was therefore available with her to meet out the household expenditure of her family consisting of two members in the financial year 2021-2023 (2021-22 & 2022-23).

It is pertinent to mention here that her husband working as Deputy Collector, Uttar Pradesh, have annual income of Rs.9,84,524/-.

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements for the financial year 2019-2021 (2019-20 & 2020-21) online against Case Id: P00000022023 and the same has been processed before Hon'ble Mr. Justice Subhash Vidyarthi, Administrative Judge, Pilibhit Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2021-2023 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. She has submitted movable and immovable property statements of the financial year 2021-2023 (2021-22 & 2022-23) vide online dated 10.07.2023. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial year 2021-2023 (2021-22 & 2022-23) of Smt. Anukriti Singh, Judicial Magistrate, Pilibhit, be laid before Hon'ble Mr. Justice Subhash Vidyarthi, Administrative Judge, Pilibhit Judgeship for His Lordship's kind perusal and orders?
