May kindly see the property statement received online from Sri Pushpendra Singh, Addl. Civil Judge (Junior Div.), Bahraich, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2021-2023 (2021-22 & 2022-23) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2021-2023 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2021-2023 (2021-22 & 2022-23), the Gross income is Rs.26,43,520/- (Rs.23,79,520/- from salary and Rs.2,64,000/- from redeemed Axis and HDFC Funds) and total deductions/savings/investment against NPS, GIS, PPF, loan repayments, SIPs/Funds and Income Tax is Rs.11,04,931/-. Thus, a sum of Rs.15,38,589/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2021-2023 (2021-22 & 2022-23) and the balance of his savings bank account(s) is also decreased by Rs.68,691/- in this financial year from previous year's balance.

It is pertinent to mention here that his wife, Mrs. Tanendra Kaur have annual income of Rs.1,25,000/- approx. from Agriculture and Tution (as mentioned by officer).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2019-2021 (2019-20 & 2020-21) online against Case Id : P00058962022 and the same has been processed before Hon'ble Mr. Justice Raj Beer Singh, Administrative Judge, Bahraich Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2021-2023 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. He has submitted movable and immovable property statements of the financial year 2021-2023 (2021-22 & 2022-23) vide online dated 29.08.2023. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial year 2021-2023 (2021-22 & 2022-23) of Sri Pushpendra Singh, Addl. Civil Judge (Junior Div.), Bahraich, be laid before Hon'ble Mr. Justice Raj Beer Singh, Administrative Judge, Bahraich Judgeship for His Lordship's kind perusal and orders?
