May kindly see the property statements online received from Smt. Nupur, Additional District & Sessions Judge (Fast Track Court), Banda regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2016-18, Total income is Rs.27,88,252/- (total Gross salary are Rs.26,15,092/- and Bank interests of Rs.1,73,160/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, CPF, Income Tax, loans, Insurance policies, PPF, SIP, RD and the balance of her savings bank account(s) is enhanced for Rs.1,30,898/-, total of which is Rs.19,80,092/-. Thus, a sum of Rs.8,08,160/- was therefore available with her to meet out the household expenditure of her family consisting three members in both the financial years.

It is pertinent to be mention here that her husband is Judicial Officer having total annual income of Rs.25,58,068/- for the financial years 2016-18.

In this connection, it is submitted that the officer has already submitted her property statement upto the financial years 2013-14 which had already been seen by Hon'ble Mr. Justice Shabihul Hasnain, the then Administrative Judge, Bulandshahar in the misc. file of the officer. And property statement of 2014-16 has been processed on e-service ID no.920.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March 2019. She has submitted movable and immovable property statements for the financial years 2016-17 & 2017-18 vide online dated 18.01.2021. As such, there is delay in submitting the property statement from the part of the officer for which she has humbly submitted that "during this period she was under treatment for Poly Cystic Ovaries Disorder. Later she was diagnosed with Uterine Fibroid and underwent surgery at Sir Gangaram Hospital, New Delhi on 26.05.2018. No sooner than she recovered, she was transferred Bulandshahar to Banda, For this reasons, she could not submit her statement within time. It was purely inadvertent for which she deeply apologised and most respectfully pray that the delay in furnishing the information may kindly be condoned, In future, she shall be careful to submit all her statements in time." mention in attachment (application dated 14.01.2021).

May, therefore, if approved, property statements for the financial years 2016-17 & 2017-18 of Smt. Nupur, Additional District & Sessions Judge (Fast Track Court), Banda be laid before Hon'ble Mr. Justice Rajesh Singh Chuahan, Administrative Judge, Banda Judgeship for His Lordship's kind perusal and orders?
