May kindly see the property statement online received from Smt. Ayushi Chaturvedi, Civil Judge (Junior Division), Hamirpur regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2021-23 (2021-22 and 2022-23) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2021-23 (2021-22 and 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial years 2021-23 (2021-22 and 2022-23), her gross income from salary is Rs.22,83,913/- and total deductions/Savings/investments against, NPS, GIS, Income Tax, Repayment of Home Loan, Mutual Fund, PPF and Insurances are Rs.7,62,756/-. The balance of Rs.13,839/- has decreased from her saving bank A/c's against the balance of the previous year. Thus a sum of Rs.15,34,996/- (Rs.15,21,157/- from salary and Rs.13,839/- from saving bank account withdrawal) was therefore available with her to meet out the household expenditure of her family consisting two members in the financial years 2021-23 (2021-22 and 2022-23).

In this connection, it is submitted that the Officer has already submitted her property statement for the financial years 2019-21 (2019-20 and 2020-21) online against case id-P00058592022 and same has been processed before Hon'ble Mr Justice Vikas Budhwar, Administrative Judge, Hamirpur Judgeship for His Lordship's kind perusal and orders. .

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2021-23 (2021-22 and 2022-23) in its next financial year i.e., 2023-24 upto March 2024. She had submitted movable and immovable property statements for the financial years 2021-23 (2021-22 and 2022-23) vide online dated 28.04.2023 on eServicesJo portal. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2021-23 (2021-22 and 2022-23) of Smt. Ayushi Chaturvedi, Civil Judge (Junior Division), Hamirpur be laid before Hon'ble Mr Justice Vikas Budhwar, Administrative Judge, Hamirpur Judgeship for His Lordship's kind perusal and orders?
