May kindly see the online property statements online received from Sri Shashi Kumar, Chief Judicial Magistrate, Prayagraj regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2021-22 & 2022-23 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2021-22 & 2022-23 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2021-22 & 2022-23, Total Gross salary (including arrears) is Rs.36,33,688/- and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, loan, SIP, Insurance policy, PPF and the balance of his savings bank account(s) has also been enhanced for Rs.1,36,750/- this financial year from previous year's balance, total of which is Rs.28,46,149/-. Thus, a sum of Rs.7,87,539/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years.

It is pertinent to mention here that his wife is Medical Officer having annual income of Rs.11,26,903/- and Rs.12,77,848/- for the financial years 2021-22 and 2022- 23 respectively.

In this connection, it is submitted that he has already submitted his property statements upto the financial year 2017-19, which has already been seen online by Hon'ble Mr. Justice Narendra Kumar Johari, the then Administrative Judge, Hathras. And property statement of the financial year 2019-21, a detailed online note has been laid before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Allahabad/Prayagraj Judgeship for His Lordship's kind perusal and orders on eService ID P00003462023.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2021-22 & 2022-23 in its next financial year i.e., 2023-24 upto March 2024. He has submitted movable and immovable property statements for the financial years 2021-22 & 2022-23 firstly vide online dated 25.05.2023. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2021-22 & 2022-23 of Sri Shashi Kumar, Chief Judicial Magistrate, Prayagraj be laid before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Allahabad/Prayagraj Judgeship for His Lordship's kind perusal and orders?
