May kindly see the property statement received online from Sri Prafful Kumar Chaudhary, Additional Civil Judge (Senior Div.)/ ACJM., Ghaziabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2020-22 (2020-21 & 2021-22), total income from salary is Rs.30,05,546/- and total deductions/savings/investment against NPS, GIS, Income Tax, PPF, SIP and the balance of his bank account(s) is also enhanced by Rs.5,57,123/- in this financial year from previous year's balance, total of which is Rs.14,74,440/-. Thus, a sum of Rs.15,31,106/- was therefore available with him to meet out the household expenditure of his family consisting five members in both of the financial years. It is pertinent to mention here that his father is a businessman, having annual income of Rs. 2,50,000/-(approx).

In this connection, it is submitted that the Officer has submitted his property statement upto the the financial year 2018-20 and the same has been approved online against Case Id: P00019562021 by Hon'ble Mr. Justice Saumitra Dayal Singh, Administrative Judge, Ghaziabad Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted his movable and immovable property statements for the financial years 2020-22 (2020-21 & 2021-22) vide online dated 24.07.23. As such, there is delay in submitting the same from the part of the officer, for which the officer has stated in the attachment letter dated 24.07.2023 that 'he could not submit the statement well in time due to heavy work load of Courts and non availability of relevant documents and he tendered unconditional apology for this delay. He further stated that he will follow the mandate of the Hon'ble High Court in future and will furnish the statements well in time'

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Prafful Kumar Chaudhary, Additional Civil Judge (Senior Div.)/ACJM., Ghaziabad be laid before Hon'ble Mr. Justice Saumitra Dayal Singh, Administrative Judge, Ghaziabad Judgeship for His Lordship's kind perusal and orders?
