May kindly see the property statement online received from Sri Hitendra Hari, Registrar (J)(Listing), High Court, Lucknow Bench, Lucknow regarding submission of statement for movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2020-22 (2020-21 & 2021-22, total income is Rs.43,05,624/- (Gross income from salary is Rs.42,29,520/- and matured amount of Bonds of Rs.76,104/-) and total deductions/repayment/ savings/ investment against NPS, GIS, Income Tax, Home loan, PPF, SIP, Insurance policies and the balance of his savings bank account(s) is enhanced for Rs.42,343/- this financial year from previous year's balance, total of which is Rs.24,60,097/-. Thus, a sum of Rs.18,45,527/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years.

It is pertinent to mention here that his wife is Associate Professor, Dept. Of Pathology, Career Institute of Medical Sciences and Hospital, Lucknow having annual income of Rs.10,69,680/- and Rs.11,84,190/- from salary in the financial years 2020-21 & 2021-22 respectively. She also earns Rs.1,28,000/- and Rs.2,46,730/- from Business & profession (private practice, Shifa pathology, Lucknow) in the financial years 2020-21 & 2021-22 respectively.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2018-20, which had already been seen by Hon'ble The Chief Justice, High Court, Allahabad in the Misc. file of the officer.

The movable and immovable property-statement for the financial years 2020-22 (2020-21 & 2021-22) had been submitted by the Officer online (e-Services portal) dated 22.08.2023. which were due to be submitted up to the end of the financial year 2022-23 i.e. 31.03.2023. As such, there is delay in submitting the same. In this regard, officer's verbatim: "Most humbly it is submitted that the property statement under consideration was submitted with delay, due to engagement in discharge of duty and due to paucity of time. Sincere efforts will be made to submit property statement within prescribed time".

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Hitendra Hari, Registrar (J) (Listing), High Court, Lucknow Bench, Lucknow be laid before Hon'ble The Chief Justice, High Court, Allahabad for His Lordship's kind perusal and orders?
