In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2018-2020 (2018-19 & 2019-20) online against Case Id: P00012352021 (Old Case Id: 3337) and the same has been processed before Hon'ble Mr. Justice Kshitij Shailendra, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2020-2022 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial year 2020-2022 (2020-21 & 2021-22) vide online dated 09.05.2023. As such, there is delay in submitting the same.
