In this connection, it is submitted that the officer has already submitted her movable and immovable property statements for the financial year 2019-2021 (2019-20 & 2020-21) online against Case Id: P00007552021 (Old Case Id: 2822) and the same has been processed before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2021-2023 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. She has submitted movable and immovable property statements of the financial year 2021-2023 (2021-22 & 2022-23) vide online dated 10.08.2023. As such, there is no delay in submitting the same.
