May kindly see the online property statements received from Sri Harendra Nath, Additional District & sessions Judge/ F.T.C., Kannauj regarding submission of complete statement of movable properties acquired/held by him or any member of his family of the financial year 2021-23 (2021-22 & 2022-23) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2021-23 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2021-23 (2021-22 & 2022-23), Total income from salary is Rs.38,36,397/- and total deductions/savings/ investment against GIS, Income Tax, NPS, PLI, PPF a/c, Insurance policies and Sukanya Samriddhi Account are Rs.15,60,267/-. Thus, a sum of Rs.22,76,130/- was therefore available with him to meet out the household expenditure of his family consisting of five members in both of the financial years. And the balance of his savings bank account(s) has also been reduced for Rs.93,194/- in this financial year from previous year's balance.

It is pertinent to mention here that his father is an Advocate having monthly income of Rs.20,000/- and his wife is Dental Surgeon having monthly income of Rs.20,000/-

In this connection, it is submitted that the officer has already submitted his property statement of the financial year 2019-21 online, which has already been seen online by Hon'ble Mr. Justice Vivek Birla, the then Administrative Judge, Allahabad.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for financial years 2021-23 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March,2024. He has submitted movable and immovable property statements of the financial year 2021-23 (2021-22 & 2022-23) firstly vide online dated 13.05.2023. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2021-23 (2021-22 & 2022-23) of Sri Harendra Nath, Additional District & sessions Judge/ F.T.C., Kannauj be laid before Hon'ble Mr. Justice Vikram D Chauhan, Administrative Judge, Kannauj for His Lordship's kind perusal and orders?
