In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2020-2022 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2020-2022 (2020-21 & 2021-22), the Gross income from salary and interest is Rs. 65,68,341/- and total deductions/savings/ investment against NPS, PPF, SIP, GIS, GVR, Fixed deposit, Income Tax, Insurances is 46,74,846/- and the balance of his savings bank account(s) is also enhanced by Rs.10,00,393/- in this financial year from previous year's balance, total of which is Rs.56,75,239/-. Thus, a sum of Rs. 8,93,102/- was therefore available with him to meet out the household expenditure of his family consisting four members in the financial year 2020-2022 (2020-21 & 2021-22) .

In this connection, it is submitted that the Officer has already submitted his property statement of the financial year 2018-20 (2018-19 & 2019-20) online against Case Id: P00009072021 (Old Case Id:2986) and the same has been processed before Hon'ble Mr. Justice Vivek Varma, Administrative Judge, Bijnor for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2020-2022 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial year 2020-2022 (2020-21 & 2021-22) vide online dated 18.05.2023. As such, there is delay in submitting the same from the part of the officer. In this regard, officer has not given reason of delay.

May, therefore, if approved, property statements for the financial year 2020-2022 (2020-21 & 2021-22) of Sri Madan Pal Singh, District & Sessions Judge, Bijnor, be laid before Hon'ble Mr. Justice Vivek Varma, Administrative Judge, Bijnor, for His Lordship's kind perusal and orders?
