May kindly see the property statement online received from Sri Sushil Kumar Kharwar, Special Judge (E.C. Act.), Hamirpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2014-16 (2014-15 & 2015-16) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2014-16 (2014-15 & 2015-16) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2014-16 (2014-15 & 2015-16), his gross income from salary is Rs.19,80,242/- and total deductions/Savings/investments against Savings in Bank account, NPS, GIS, Income Tax, Repayment of Car loan, Insurance and PPF is Rs.7,46,185/-. The balance of Rs.31,189/- has increased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.12,34,057/- was therefore available with him to meet out the household expenditure of his family consisting five members in the financial years 2014-16 (2014-15 & 2015-16).

In this connection, it is submitted that the Officer has already submitted his property statement up to the financial years 2013-14, which has already been seen by Hon'ble Mr Justice R.D. Khare, the then Administrative Judge, Jhansi Judgeship in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2014-16 (2014-15 & 2015-16) in its next financial year i.e., 2016-17 upto March 2017. He has firstly submitted movable and immovable property statements for the financial years 2014-16 (2014-15 & 2015-16) vide letter dated 29.03.2019 in the Misc. file of the officer. As such, there is delay in submitting the same. In this regard: officer has stated that due to infection in chest and suffering from dengue the officer had not submitted property-statement on time, officer has apologized for delay.

May, therefore, if approved, property statements for the financial years 2014-16 (2014-15 & 2015-16) of Sri Sushil Kumar Kharwar, Special Judge (E.C. Act.), Hamirpur be laid before Hon'ble Mr. Justice Syed Aftab Husain Rizvi, Administrative Judge, Hamirpur Judgeship for His Lordship's kind perusal and orders?
