In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2016-18 (2016-17 & 2017-18), his gross income from salary is Rs.25,46,895/- and total deductions/Savings/investments against Savings in Bank account, NPS, GIS, Income Tax, Repayment of Car loan, Insurance and PPF is Rs.13,49,358/-. The balance of Rs.3,73,404/- has increased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.11,97,537/- was therefore available with him to meet out the household expenditure of his family consisting five members in the financial years 2016-18 (2016-17 & 2017-18).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2014-16 (2014-15 & 2015-16) online against case id: P00003982023 and same has been processed before Hon'ble Mr. Justice Syed Aftab Husain Rizvi, Administrative Judge, Hamirpur Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. He has firstly submitted movable and immovable property statements for the financial years 2016-18 (2016-17 & 2017-18) vide letter dated 29.03.2019 in the Misc. file of the officer. As such, there is no delay submitting the same.

May, therefore, if approved, property statements for the financial years 2016-18 (2016-17 & 2017-18) of Sri Sushil Kumar Kharwar, Special Judge (E.C. Act.), Hamirpur be laid before Hon'ble Mr. Justice Syed Aftab Husain Rizvi, Administrative Judge, Hamirpur Judgeship for His Lordship's kind perusal and orders?
