May kindly see the property statement received online from Sri Harendra Prasad, Special Judge (SC/ST, Prevention of Atrocities Act), Mathura regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2020-2022 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2020-2022 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2020-2022 (2020-21 & 2021-22), the Gross income is Rs.72,83,276/- (Rs.44,20,140/- from salary, Rs.26,01,534/- from maturity of PPF and Rs.2,61,602/- from SB account interest) and total deductions/savings/investment against GIS, GPF, PPF, Plot purchase and Income Tax are Rs.55,87,988/-. Thus, a sum of Rs.16,95,288/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2020-2022 (2020-21 & 2021-22) and the balance of his savings bank account(s) is also decreased by Rs.35,90,991/- in this financial year from previous year's balance.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2018-2020 (2018-19 & 2019-20) online against Case Id : P00009472021 (Old Case Id : 3030) and the same has been seen by Hon'ble Mr. Justice Rajnish Kumar, Administrative Judge, Mathura Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2020-2022 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial year 2020-2022 (2020-21 & 2021-22) vide online dated 29.05.2023. As such, there is some delay in submitting the same from the part of the officer. In this regard, the officer has stated that due to excessive judicial and administrative work, the property statement were not sent on time, for that the officer apologizes and assures that the statement will be sent on time in future.

May, therefore, if approved, property statements for the financial year 2020-2022 (2020-21 & 2021-22) of Sri Harendra Prasad, Special Judge (SC/ST, Prevention of Atrocities Act), Mathura, be laid before Hon'ble Mr. Justice Rajnish Kumar, Administrative Judge, Mathura Judgeship for His Lordship's kind perusal and orders?
