

## **Registrar(J)(Budget)**

May kindly see the online reply dated 31.08.2023 received from Sri Ankit Kumar Mittal, Addl. District & Sessions Judge, Farrukhabad, in compliance of order of Hon'ble Mrs. Justice Sadhna Rani (Thakur), Administrative Judge, Maharajganj in the matter of property statements of the financial years 2021 - 2023 (2021-22 & 2022-23), communicated to the officer.

In this connection, it is submitted that the officer had submitted his movable & immovable property statements of the financial years 2021 - 2023 (2021-22 & 2022-23), which was put up before Hon'ble the Administrative Judge, Maharajganj through detailed office note dated 07.06.2023, on which Her Lordship has been pleased to pass the following order dated 30.08.2023:

"Officer may be asked to file the copy the passbooks of the officer himself and his wife showing the payment of 3 lakh each made to Ram Avtar on 19.07.2016."

The order of the Court had been communicated to the officer concerned on 30.08.2023.

In reply/compliance of the Hon'ble Court's Order, the officer concerned has attached the copy the passbooks of himself and his wife showing the payment of 3 lakh each made to Ram Avtar on 19.07.2016 as attachment which is subjected as "Ankit Bank Entry 19-07-2016" and "Radha Bank Entry 19-07-2016" respectively.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2021-23 (2021-22 and 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2021-23 (2021-22 and 2022-23), Gross income from salary and other sources is Rs.50,23,110/- and total deductions/savings/ investment against NPS, GIS, PPF, Income Tax, Insurance, Mutual Funds, Sukanya Samridhi Yojna, repayment of car loan and down payment and the balance of his savings bank account(s) is also enhanced by Rs.7,64,456/- in this financial year from previous year's balance, total of which is Rs.31,28,729/-. Thus, a sum of Rs.11,29,925/-was therefore available with him to meet out the household expenditure of his family consisting four members in the the financial years 2021-23 (2021-22 and 2022-23).

It is pertinent to mention here that the Officer's wife (Tuition teacher) annual income was Rs.6,60,000/- for the financial years 2021-22 & 2022-23.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2019-21 (2019-20 & 2020-21) online against case id P00059942022, which has been seen by Hon'ble Mr. Justice Ajit Singh, the then Administrative Judge, Maharajganj.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2021-23 (2021-22 and 2022-23) in its next financial year i.e., 2023-24 upto March 2024. He has submitted movable and immovable property statements of the financial years 2021-23 (2021-22 and 2022-23) vide online dated 31.05.2023. As such, there is no delay in submitting the same.

May therefore, if approved, movable & immovable property statement of the financial years 2021 - 2023 (2021-22 & 2022-23) alongwith the reply/ compliance of Hon'ble Court's order, as desired by the Court in the matter, furnished by Sri Ankit Kumar Mittal, Addl. District & Sessions Judge, Farrukhabad, be laid before Hon'ble Mr. Justice Shekhar Kumar Yadav, Administrative Judge, Farrukhabad Judgeship for Her Lordship's kind perusal and orders?
