May kindly see the online property statements received from Sri Ajay Singh-I, A.D.J. (FTC), Fatehpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, total Gross income from salary is Rs.45,49,796/- and total deductions/ repayment/ savings/ investment against GIS, GPF, Income Tax, PPF a/c and the balance of his savings bank account(s) is enhanced for Rs.16,42,417/- this financial year from previous year's balance, total of which is Rs.34,13,606/-. Thus, a sum of Rs.11,36,190/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2011-12, which has already been seen offline by Hon'ble Mr. Justice Amar Saran, the then Administrative Judge, Moradabad, placed in the misc. file of the officer. Property statements of the financial years 2012-13 & 2013-14, 2014-15 & 2015-16 and 2016-17 & 2017-18 have been processed on e-Service IDs P00004152023, P00004162023 and P00004172023 respectively and detailed office notes have been submitted on the same.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-19 & 2019-20 firstly vide online dated 31.05.2023. As such, there is delay in submitting the same from the part of the officer for which he has stated that "Due to heavy work load and some other family problems the statement were not submitted within due time for which he seeks unconditional apology", mentioned in remark column of movable proforma.

May, therefore, if approved, property statements for the financial years 2018-19 & 2019-20 of Sri Ajay Singh-I, A.D.J. (FTC), Fatehpur be laid before Hon'ble Mr. Justice Dinesh Pathak, Administrative Judge, Fatehpur Judgeship for His Lordship's kind perusal and orders?
