May kindly see the property statement received online from Sushri Shirin Zaidi, Special Judge (SC/ST, Pev.of Atroci Act), Kaushambi regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2019-2021 (2019-20 & 2020-21) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2019-2021 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial year 2019-2021 (2019-20 & 2020-21), the Gross income from salary is Rs.28,65,424/- and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, PPF and Mutual Funds are Rs.6,58,648/- and the balance of her savings bank account is also increased by Rs.33,445/- in this financial year from previous year's balance, total of which is Rs.6,92,093/-. Thus, a sum of Rs.21,73,331/- was therefore available with herself to meet out the household expenditure in the financial year 2019-2021 (2019-20 & 2020-21).

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements held at the time of joining into U.P. Judicial Service online against Case Id: P00004202023 and the same has been processed before Hon'ble Mr. Justice Surendra Singh-I, Administrative Judge, Kaushambi Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2019-2021 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She has firstly submitted movable and immovable property statements of the financial year 2019-2021 (2019-20 & 2020-21) vide online dated 02.06.2023. As such, there is delay in submitting the same from the part of the officer for which she has stated in her online reply dated 03.09.2024, that "I am submitting the updated property statement as directed. I could not do it earlier due to COVID pandemic. My whole family was suffering from COVID virus. I apologise for the delay."

May, therefore, if approved, property statements for the financial year 2019-2021 (2019-20 & 2020-21) of Sushri Shirin Zaidi, Special Judge (SC/ST, Pev.of Atroci Act), Kaushambi, be laid before Hon'ble Mr. Justice Surendra Singh-I, Administrative Judge, Kaushambi Judgeship for His Lordship's kind perusal and orders?
