May kindly see the property statement received online from Sri Gyanendra Kumar-II, Addl. Civil Judge (Sr.Div.)/ACJM., Gorakhpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2018-2020 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2018-2020 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2018-2020 (2018-19 & 2019-20), the Gross income from salary is Rs.19,77,812/- and total deductions/savings/investment against GIS, NPS, PPF, Insurances and Income Tax is Rs.6,07,301/- and the balance of his savings bank account(s) is also increased by Rs.6,69,860/- in this financial year from previous year's balance, total of which is Rs.12,77,161/-. Thus, a sum of Rs.7,00,651/- was therefore available with him to meet out the household expenditure of his family consisting three members of the financial year 2018-2020 (2018-19 & 2019-20).

It is pertinent to mention here that his wife is a PCS Officer, having annual gross salary about 8 lacs (as mentioned by officer).

In this connection, it is submitted that the Officer has already submitted his property statements for the financial year 2016-2018 (2016-17 & 2017-18) online against Case Id: P00001512020 (Old Case Id: 732) and the same have been seen by Hon'ble Mr. Justice Alok Singh, the then Administrative Judge, Bareilly Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2018-2020 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has firstly submitted movable and immovable property statements of the financial year 2018-2020 (2018-19 & 2019-20) vide online dated 01.07.2023. As such, there is delay in submitting the same from the part of officer, for which he has stated in his online reply dated 10.04.2024, that "I had already submitted the property statements but I had been informed that the financial year were not proper then I had to withdraw the submitted property statements. After that I had submitted the property statements. I therefore request you to kindly place the property statements before th Hon'ble Court."

May, therefore, if approved, property statements for the financial year 2018-2020 (2018-19 & 2019-20) of Sri Gyanendra Kumar-II, Addl. Civil Judge (Sr.Div.)/ACJM., Gorakhpur, be laid before Hon'ble Mr. Justice Shekhar B. Saraf, Administrative Judge, Gorakhpur Judgeship for His Lordship's kind perusal and orders?
