May kindly see the property statement received online from Sri Gyanendra Kumar-II, Addl. Civil Judge (Sr.Div.)/ACJM., Gorakhpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2020-2022 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2020-2022 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2020-2022 (2020-21 & 2021-22), the Gross income from salary is Rs.31,08,437/- and total deductions/savings/investment against GIS, NPS, PPF, Insurances and Income Tax is Rs.11,02,115/- and the balance of his savings bank account(s) is also increased by Rs.6,67,559/- in this financial year from previous year's balance, total of which is Rs.17,69,674/-. Thus, a sum of Rs.13,38,763/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2020-2022 (2020-21 & 2021-22).

It is pertinent to mention here that his wife is a PCS Officer, having annual gross salary about 10 lacs (as mentioned by officer).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2018-2020 (2018-19 & 2019-20) online against Case Id : P00004262023 and the same has been processed before Hon'ble Mr. Justice Shekhar B. Saraf, Administrative Judge, Gorakhpur Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2020-2022 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial year 2020-2022 (2020-21 & 2021-22) vide online dated 01.07.2023. As such, there is delay in submitting the same from the part of officer, for which he has stated in his online reply dated 26.03.2024, that *"I had submitted the property statements. I had been informed that the financial year is wrong that I had mentioned in the property statements. So I had withdrawn the property statements and I submitted the property statements as per FY informed me about. I therefore request you to kindly place the property statements before the Hon'ble Court."*

May, therefore, if approved, property statements for the financial year 2020-2022 (2020-21 & 2021-22) of Sri Gyanendra Kumar-II, Addl. Civil Judge (Sr.Div.)/ACJM., Gorakhpur, be laid before Hon'ble Mr. Justice Shekhar B. Saraf, Administrative Judge, Gorakhpur Judgeship for His Lordship's kind perusal and orders?
