May kindly see the online property statements received from Sri Ashok Kumar-IX, Principal Judge, Family Court, Farrukhabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2016-17 & 2017-18, Total income is Rs.31,02,899/- (Gross income from salary is Rs.31,00,712/- and bank interests of Rs.2,187/-) and total deductions/ repayment/ savings/ investment against GIS, GPF, Income Tax, Insurance policies, PPF a/c, Home loan, Gold bond and Mutul Fund are Rs.11,51,421/-. Thus, a sum of Rs.19,51,478/- was therefore available with him to meet out the household expenditure of his family consisting four members in both of the financial years. And the balance of his savings bank account(s) has also been reduced for Rs.1,76,455/- this financial year from previous year's balance.

In this connection, it is submitted that he has already submitted his property statement upto the financial year 2013-14, which has already been seen by Hon'ble Mr. Justice Ashok Pal Singh, the then Administrative Judge, Basti, placed in the misc. file of the officer. And property statement of the financial years 2014-16, a detailed note has been laid online before Hon'ble Mr. Justice Shekhar Kumar Yadav, Administrative Judge, Farrukhabad Judgeship for His Lordship's kind perusal and orders on eService ID P00004282023.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements of the financial years 2016-17 & 2017-18 firstly vide offline dated 11.04.2019. As such, there is delay in submitting the same from the part of the officer for which he has stated (in his verbatim) that *"he has submitted the aforesaid statement offline on 11.04.2019 however, in the meantime, being transferred to another district and on medical leave because of an accident, the details forms of movable and immovable property got disorganized, due to which, there has been a delay in sending information on the portal. Therefore, he has requested for condoning the delay, please be kind enough to submit the above statement form before the Hon'ble Court for approval"*, mentioned in his attachment letter dated 16.09.2023.

May, therefore, if approved, property statements for the financial year 2016-17 & 2017-18 of Sri Ashok Kumar-IX, Principal Judge, Family Court, Farrukhabad be laid before Hon'ble Mr. Justice Shekhar Kumar Yadav, Administrative Judge, Farrukhabad Judgeship for His Lordship's kind perusal and orders?
