May kindly see the property statements online received from Sri Dushyant Kumar Sharma, Civil Judge (Junior Div.), Pilibhit regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2019-20 & 2020-21 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019-20 & 2020-21 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

In the financial years 2019-20 & 2020-21, Total income is Rs.14,25,780/- (Gross income from salary & arrears are Rs.13,93,980/-, LIC returns of Rs.24,000/- and Interests of Rs.7,800/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, PPF, Insurance policies, Income Tax, NPS, Car loan and the balance of his savings bank account(s) is enhanced for Rs.54,524/- this financial year from previous year's balance, total of which is Rs.3,46,154/-. Thus, a sum of Rs.10,79,626/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

In this connection, it is submitted that the officer has submitted his property statement at the time of entering into judicial service online which had been processed on eService ID- P00032092021 (old case id no. 5353).

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2019-20 & 2020-21 in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial years 2019-20 & 2020-21 firstly vide online dated 24.07.2023. As such, there is delay in submitting the same from the part of the officer for which he has stated that "Due to missing of some passbooks and paper, he could not submit the property statement in time so he regrets for this and seeks apology to Hon'ble high court and requested to accept his sincere apology for delay." mentioned in remark column of movable proforma..

May, therefore, if approved, property statements of the financial years 2019-20 & 2020-21 of Sri Dushyant Kumar Sharma, Civil Judge (Junior Div.), Pilibhit be laid before Hon'ble Mr. Justice Subhash Vidyarthi, Administrative Judge, Pilibhit Judgeship for His Lordship's kind perusal and orders?
