May kindly see the property statement online received from Sri Virek Aggarwal, Additional Civil Judge (Sr. Div.)/ Additional Chief Judicial Magistrate, Prayagraj regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2018-20 (2018-19 & 2019-20), his gross income from salary is Rs.19,71,616/- and total deductions/Savings/investments against Savings in Bank account, NPS, GIS, Income Tax, PPF, FD and Insurances is Rs.10,60,691/-. The balance of Rs.1,72,121/- has decreased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.10,83,046/- (Rs.9,10,925/- from salary and Rs.1,72,121/- from saving bank account) was therefore available for himself in the financial years 2018-20 (2018-19 & 2019-20).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2016-18 (2016-17 & 2017-18) online against case id-P00009502021 (old case id-3033) and same has been processed before Hon'ble Mr. Justice Attau Rahman Masoodi, Administrative Judge, Allahabad for His Lordship's kind perusal and orders .

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted firstly movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) vide dated 15.04.2019 in the Misc. file of the officer. As such, there is delay in submitting the same. In this regard, officer verbatim: **"I had joined the Judicial Services on 12.01.2017. Thereafter, till March 30, 2017, I was on Dais training and held court only for 2 days, during which I was under impression, that the Financial Statement is required to be send every after 2 years. Accordingly, first Financial Statement was sent by me on 15.4.2019, for financial year 2017-2018, 2018-2019, disclosing all the Bank details and Moveable Assets, possessed / held by me as on 1.4.2019. That said Financial Statement, was duly sent under cover letter, bearing No. 519/19 dt.17.4.2019 , forwarded by Respected District Judge, Sambhal at Chandausi. Thereafter, Second Financial Statement for the year 2019-20, 2020-21 has been submitted in November 2021 through online portal in the prescribed format. However, spouse Assets could not be disclosed, inasmuch as, Divorce Litigation of the undersigned was pending. That after the Decree of Divorce had been granted in October 2021, the statement has been duly submitted in November 2021 through online format. Inconvenience caused to your godd office is regretted"**

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Virek Aggarwal, Additional Civil Judge (Sr. Div.)/ Additional Chief Judicial Magistrate, Prayagraj be laid before Hon'ble Mr. Justice Attau Rahman Masoodi, Administrative Judge, Allahabad for His Lordship's kind perusal and orders?
