May kindly see the property statement received online from Km Anita-I, Addl. District & Sessions Judge, Prayagraj regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2021-2023 (2021-22 & 2022-23) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2021-2023 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

**In the financial year 2021-2023 (2021-22 & 2022-23)**, the Gross income is Rs.71,06,834/- (Rs.48,81,834/- from salary and Rs.22,25,000/- from financial support of her siblings) and total deductions/repayment/savings/investment against GIS, NPS, Income Tax, PPF, Car and Home Loan Repayment including amount other than Home Loan and Insurances are Rs.61,36,968/- and the balance of her savings bank account is also decreased by Rs.5,00,546/- in this financial year from previous year's balance. Thus, a sum of Rs.14,70,412/- (Rs.9,69,866/- from Salary and Rs.5,00,546/- from SB account) was therefore available with herself in the financial year 2021-2023 (2021-22 & 2022-23).

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements of the financial year 2019-21 (2019-20 & 2020-21) online against Case Id : P00018252021 (old case id : 3945) and the same has been processed before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Allahabad Judgship for Her Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2021-2023 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. She has firstly submitted movable and immovable property statements of the financial year 2021-2023 (2021-22 & 2022-23) vide online dated 27.06.2023. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial year 2021-2023 (2021-22 & 2022-23) of Km Anita-I, Addl. District & Sessions Judge, Prayagraj, be laid before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Allahabad Judgship for Her Lordship's kind perusal and orders?
