

## **Registrar(J)(Budget)**

May kindly see the property statement online received from Sri Ram Kishor-III, A.D.J. (POCSO), Mathura regarding submission of statement for movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

**In the financial years 2020-22 (2020-21 & 2021-22)**, his gross income from salary is Rs.41,26,029/- and total deductions/Savings/investments against GPF, GIS, Income Tax, PPF, Mutual Funds and Insurances are Rs.26,49,866/-. The balance of Rs.2,740/- has increased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.14,76,163/- was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2020-22 (2020-21 & 2021-22).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2018-20 (2018-19 & 2019-20) online against case id:P00046602021 (old case id:6817) and same has been processed before Hon'ble Mr. Justice Sanjay Kumar Singh, Administrative Judge, Mathura Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements for the financial years 2020-22 (2020-21 & 2021-22) vide online dated 21.06.2023. As such, there is delay in submitting the same. In this regard officer's verbatim: "ससम्मान अवगत कराना है कि मेरे प्रोपर्टी स्टेटमेन्ट में लिपिकीय त्रुटिवश वित्तीय वर्ष 2020-2022 के स्थान पर 2021-2023 अंकित हो गया है। इस त्रुटि को मेरे द्वारा दुरुस्त कर दिया गया है। अतः माननीय महोदय से निवेदन है कि मेरे प्रोपर्टी स्टेटमेन्ट वित्तीय वर्ष 2020-2022 को स्वीकार करते हुए प्रोपर्टी स्टेटमेन्ट दाखिल करने में हुए विलम्ब को क्षमा करने की कृपा करें।"
