

## **Registrar(J)(Budget)**

May kindly see the property statement received online from Sri Yogesh Kumar-II, Addl. District & Sessions Judge, Kanpur Nagar, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2009-11 (2009-10 & 2010-11) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2009-11 (2009-10 & 2010-11) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

**(1) In the financial year 2009-11 (2009-10 & 2010-11)**, the Gross income from salary is Rs.7,63,774/- and total deductions/savings/investment against NPS, GIS, Arr., PPF, Income Tax and Car Loan Repayment is 1,69,330/- and the balance of his savings bank account(s) is also increased by Rs.93,181/- in this financial year from previous year's balance, total of which is Rs.2,62,511/-. Thus, a sum of Rs.5,01,263/- was therefore available with him to meet out the household expenditure of his family consisting three members of the financial year 2009-11 (2009-10 & 2010-11).

It is also pertinent to mention here that the officer's father annual income approx. Rs.1,50,000/- from Advocacy and Agriculture.

In this connection, it is submitted that the Officer has already submitted his property statement at the time of joining and the same has been seen by Hon'ble Mr. Justice A. P. Sahi, the then Administrative Judge, Rampur Judgeship in the misc file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2009-11 (2009-10 & 2010-11) in its next financial year i.e., 2011-12 upto March 2012. In this regard, earlier the officer has submitted movable and immovable property statements of the financial year 2009-11 (2009-10 & 2010-11) vide his offline letter dated 13.06.2013 along with reason for delay which is mentioned in officer's verbatim that "*I could not sent the required partifulars of properties in time because being a new entrant in the service I am unaware of the fact that my property statement was already due for submission. Besides this my Annual Transfer was due in march- april 2012 and for transfer purpose my belongings and documents were in process of packing and reshuffling and also due to excess of Judicial work I was unable to submit the required particulars in time. Delay in this regard is highly regretted. I deeply regret and submit my humble apology*". Further, Objection has been raised vide High Court offline letter no. 7755/IV-3618/Admin (A-4)/ dated 30.05.2023 and officer was asked to furnish the revised property statement (as some informations were missing) for the financial year 2009-11 (2009-10 & 2010-11) online in given prescribed proforma on e-services portal. Accordingly, the officer has submitted revised movable and immovable property statements of the financial year 2009-11 (2009-10 & 2010-11) vide online dated 27.06.2023.

May, therefore, if approved, property statements for the financial year 2009-11 (2009-10 & 2010-11) of Sri Yogesh Kumar-II, Addl. District & Sessions Judge, Kanpur Nagar, be laid before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Kanpur Nagar Judgeship for His Lordship's kind perusal and orders?
