May kindly see the property statement received online from Sri Avinash Chandra Gautam, Additional Chief Judicial Magistrate, Lakhimpur Kheri regarding submission of complete statement of movable properties acquired/held by him or any member of his family of the financial year 2021-23 (2021-22 & 2022-23) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2021-23 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial year 2021-23 (2021-22 & 2022-23), Total income is Rs.35,85,076/- (Gross Salary is Rs.35,68,654/- and interest from other sources is Rs.16,422/-) and total deductions/savings/ investment against GIS, Income Tax, PPF, LIC, Sukanya Samriddhi Account and the balance of his savings bank account(s) is also enhanced by Rs.3,54,661/- in this financial year from previous year's balance, total of which is Rs.12,11,424/-. Thus, a sum of Rs.23,73,652/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial years 2021-23 (2021-22 & 2022-23).

It is pertinent to mention here that the Officer's wife earns Rs.2,50,000/- per annum from her profession as a lawyer and Home tuition for the financial years 2021-22 & 2022-23.

In this connection, it is submitted that the Officer has already submitted his property statement of the financial year 2019-21 online, which has been seen online by Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Lakhimpur Kheri.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for financial years 2021-23 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. He has submitted movable and immovable property statements of the financial year 2021-23 (2021-22 & 2022-23) vide online dated 06.07.2023. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2021-23 (2021-22 & 2022-23) of Sri Avinash Chandra Gautam, Additional Chief Judicial Magistrate, Lakhimpur Kheri be laid before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Lakhimpur Kheri for His Lordship's kind perusal and orders?
