In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial years 2020-22 (2020-21 & 2021-22), her gross income from salary is Rs.50,59,870/- and total deductions/Savings/investments against GPF, GIS, Income Tax, PPF and Insurance is Rs.27,27,142/-. The balance of Rs.67,465/- has decreased from her saving bank A/c's against the balance of the previous year. Thus a sum of Rs.24,00,193/- (Rs.23,32,728/- from salary and Rs.67,465/- from saving bank account withdrawal) was therefore available with her to meet out the household expenditure of her family consisting three members in the financial years 2020-22 (2020-21 & 2021-22).

It is pertinent mention here that's Officer's Husband (Retd. A.D.J.) having annual income was Rs.31,01,141/- for the financial year 2020-21 & Rs.11,11,936/- for the financial year 2021-22 respectively.

In this connection, it is submitted that the Officer has already submitted her property statement for the financial years 2018-20 (2018-19 & 2019-20) online against case id- P00046662021 (Old Case Id:6823) and same has been processed before Hon'ble Mr. Justice Siddharth, Administrative Judge, Gonda Judgeship for His Lordship's kind perusal and orders...

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. She has submitted movable and immovable property statements for the financial years 2020-22 (2020-21 & 2021-22) vide online dated 27.07.2023 on eServicesJo portal. As such, there is some month delay.
