May kindly see the property statement online received from Sri Kamesh Shukla, Additional District Judge (FTC), Siddharth Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2021-23 (2021-22 & 2022-23) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2021-23 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2021-23 (2021-22 & 2022-23), his gross income from salary is Rs.50,05,213/- and total deductions/Savings/investments against NPS, GIS, Income Tax, PPF, LIC, personal loan, NSC and the balance of his savings bank account is also enhanced by Rs.1,63,440/- in this financial year from previous year's balance, total of which is Rs.21,87,183/-. Thus a sum of Rs.28,18,030/- was therefore available with him to meet out the household expenditure of his family consisting five members in both the financial years.

It is pertinent to mention here that Officer's father is retired from U.P. Government service, having annual income of Rs.2,00,000/- (approx) and his wife's annual income is Rs.3,15,930/- & 3,80,720/- for the financial year 2021-22 & 2022-23 respectively, as mentioned by the officer.

In this connection, it is submitted that the Officer has already submitted his property statement upto the financial years 2019-21 and the same has been processed online against case id-P00006392021 before Hon'ble Mr. Justice Subhash Chandra Sharma, Administrative Judge, Siddharth Nagar for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2021-23 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. He has submitted movable and immovable property statements of the financial years 2021-23 (2021-22 & 2022-23) vide online dated 15.02.2024. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2021-23 (2021-22 & 2022-23) of Sri Kamesh Shukla, Additional District Judge (FTC), Siddharth Nagar be laid before Hon'ble Mr. Justice Subhash Chandra Sharma, Administrative Judge, Siddharth Nagar for His Lordship's kind perusal and orders?
