May kindly see the property statement online received from Sri Satya Nand Upadhyaya, Principal Judge, Family Court, Muzaffar Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2018-20 (2018-19 & 2019-20), Gross income from salary and other sources Rs.47,02,398/-(income from salary is Rs.45,22,398/-, income from LIC Policy Rs.80,000/- and income from PPF a/c Rs.1,00,000/-) and total deductions/savings/ investment against GPF, GIS, Income Tax, PPF, LIC policy and repayment of car & home loan are Rs.23,17,169/-. Thus, a sum of Rs.23,85,229/- was therefore available with him to meet out the household expenditure of his family consisting of four member in the both of the financial year. And the balance of his savings bank account(s) is also decreased by Rs.43,371/- in this financial year from previous year's balance.

In this connection, it is submitted that the Officer has already submitted his property statement of the financial year 2016-18 offline and same has been seen by Hon'ble Mr. Justice Ram Surat Ram (Maurya), the then Administrative Judge, Gorakhpur in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial year 2018-20 (2018-19 & 2019-20) firstly vide online dated 10.06.2020. As such, there is no delay in submitting the same from part of the officer.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Satya Nand Upadhyaya, Principal Judge, Family Court, Muzaffar Nagar be laid before Hon'ble Mr. Justice Salil Kumar Rai, Administrative Judge, Muzaffar Nagar for His Lordship's kind perusal and orders
