May kindly see the property statement submitted online received from Smt. Meenu Sharma, Special Judge(SC/ST prv. of Atroci. Act), Auriaya regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

In the financial year 2018-20 (2018-19 & 2019-20), her total income from salary is Rs. 49,75,801/- and total deductions/savings/investments against GPF, GIS, Income Tax, PPF, LIC, FD and the balance of his Saving bank A/c(s) is enhanced for Rs. 10,31,296/- this financial year from previous year's balance, total of which is Rs.26,86,973/-. Thus a sum of Rs.22,88,828/- was therefore available with her to meet out the household expenditure of her family consisting four members in both the financial years.

It is pertinent to mention here that the Officer's husband Professor (Dr.) Harish Kumar Sharma, Director, National Institute of Technology (An Institute of National Importance), Agartala{Tripura} Income, Rs 300000 per month from salary (approximate) in this financial year.

In this connection, it is submitted that the officer has already submitted her property statements Upto the financial years 2016-18 which had already been seen by Hon'ble Mr. Justice Ramesh Sinha, the then Administrative Judge, Ghaziabad in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit her property statements for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. She has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) firstly vide her application dated 22.01.2021. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Smt. Meenu Sharma, Special Judge(SC/ST preventon of Atrocities Act), Auriaya, be laid before Hon'ble Mrs. Justice Sadhna Rani (Thakur), Administrative Judge, Auraiya for Her Lordship's kind perusal and orders?
