In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2021-23 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2021-23 (2021-22 & 2022-23), his gross income from salary is Rs.40,91,774/and total deductions/Savings/investments against, NPS, GIS, Income Tax and Repayment of home Loan, PPF, RD, Insurances and Mutual Funds are Rs.26,02,023/-. The balance of Rs.20,161/- has decreased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.15,09,912/-(Rs.14,89,751/- from salary and Rs.20,161/- from saving bank account withdrawal) was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2021-23 (2021-22 & 2022-23).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2019-21 (2019-20 & 2020-21) online against case id- P00009552021 (old case id-3038) and same has been processed before Hon'ble Mr. Justice Alok Mathur, Administrative Judge, Saharanpur Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2021-23 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. He has submitted movable and immovable property statements for the financial years 2021-23 (2021-22 & 2022-23) vide online dated 09.08.2023. As such, there is no delay in submitting the same.
