May kindly see the property statement received online from Sri Subodh Bharti, Addl. Principal Judge, Family Court, Sitapur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2020-2022 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2020-2022 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2020-2022 (2020-21 & 2021-22), the Gross income from salary is Rs.41,14,529/- and total deductions/savings/investment against GIS, NPS, PPF and Income Tax is Rs.14,16,241/-. Thus, a sum of Rs.26,98,288/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2020-2022 (2020-21 & 2021-22) and the balance of his savings bank account(s) is also decreased by Rs.3,73,300/- in this financial year from previous year's balance.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2018-2020 (2018-19 & 2019-20) online against Case Id : P00008502020 (Old Case Id : 1714) and the same has been seen by Hon'ble Mr. Justice Karunesh Singh Pawar, the then Administrative Judge, Sitapur Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2020-2022 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial year 2020-2022 (2020-21 & 2021-22) vide online dated 08.08.2023. As such, there is delay in submitting the same from the part of officer for which he has sincerely apologized in his online reply dated 25.09.2024 that he was not aware that the property statement/details are filled only till the month of March of the financial year.

May, therefore, if approved, property statements for the financial year 2020-2022 (2020-21 & 2021-22) of Sri Subodh Bharti, Addl. Principal Judge, Family Court, Sitapur, be laid before Hon'ble Mr. Justice Manoj Bajaj, Administrative Judge, Sitapur Judgeship for His Lordship's kind perusal and orders?
