May kindly see the property statement received online from Smt. Trisha Mishra, Chief Judicial Magistrate, Moradabad, regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2020-2022 (2020-21 & 2021-22) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2020-2022 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial year 2020-2022 (2020-21 & 2021-22), the Gross income from salary and arrears is Rs.37,10,447/- and total deductions/ repayment/ savings/ investment against GIS, PPF, NPS, SIP/Mutual Fund, Car Loan repayment including down payment, PLI and Income Tax are Rs.21,76,759/- and the balance of her savings bank account is also increased by Rs.72,266/- in this financial year from previous year's balance, total of which is Rs.22,49,025/-. Thus, a sum of Rs.14,61,422/- was therefore available with her to meet out the household expenditure of her family consisting two members of the financial year 2020-2022 (2020-21 & 2021-22).

It is also pertinent to mention here that the her husband is a Judicial Officer whose gross income is approx. Rs.16,55,078/- & Rs.17,43,738/- for the financial year 2020-21 & 2021-22 respectively.

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements of the financial year 2018-2020 (2018-19 & 2019-20), online against Case Id: P00006032023 and the same has been processed before Hon'ble Mr. Justice Rajeev Misra, Administrative Judge, Moradabad Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2020-2022 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. She has firstly submitted her movable and immovable property statements of the financial year 2020-2022 (2020-21 & 2021-22) vide online dated 01.09.2023. As such, there is delay in submitting the same for which the officer has stated in her application as attachment dated 29.08.2023, that the delay in submission of the property statements caused due to excessive workload.

May, therefore, if approved, property statements for the financial year 2020-2022 (2020-21 & 2021-22) of Smt. Trisha Mishra, Chief Judicial Magistrate, Moradabad, be laid before Hon'ble Mr. Justice Rajeev Misra, Administrative Judge, Moradabad Judgeship for His Lordship's kind perusal and orders?
