

## **Registrar(J)(Budget)**

May kindly see the property statements online received from Sri Amarendra Kumar Verma, Addl. Civil Judge, (Junior Div.), Saharanpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2021-22 & 2022-23 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2021-22 & 2022-23 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2021-22 & 2022-23, Total income from salary are Rs.23,65,103/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, PPF, car loan and the balance of his savings bank account(s) is enhanced for Rs.31,423/- this financial year from previous year's balance, total of which is Rs.8,34,062/-. Thus, a sum of Rs.15,31,041/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years.

It is pertinent to mention here that his wife is working as Senior Consultant in IIFL Wealth Services Ltd., having annual income of Rs.12,00,000/-.

In this connection, it is submitted that officer has already submitted his property statement held at the time of joining into judicial service online against case id-P00004352021 (Old case Id-2465), and for the financial year 2019-20 & 2020-21 online against case id -P00059292022, and the same has been submitted before Hon'ble Mr. Justice Neeraj Tiwari, Administrative Judge, Saharanpur Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2021-22 & 2022-23 in its next financial year i.e., 2023-24 upto March 2024. He has submitted movable and immovable property statements of the financial years 2021-22 & 2022-23, vide online dated 18.08.2023. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements of the financial year 2021-22 & 2022-23 of Sri Amarendra Kumar Verma, Addl. Civil Judge, (Junior Div.), Saharanpur be laid before Hon'ble Mr. Justice Neeraj Tiwari, Administrative Judge, Saharanpur Judgeship for His Lordship's kind perusal and orders?
