May kindly see the property statement received online from Sri Vinay Kumar Jaiswal, A.C.J.M. (Railway), Moradabad, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2019-2021 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2019-2021 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2019-2021 (2019-20 & 2020-21), the Gross income is Rs.34,09,592/- (Rs.32,90,393/- from salary, Rs.40,379/- from withdrawal of Nippon India small cap and Rs.78,820/- from withdrawal of ICICI Prudential Value Discovery Fund) and total deductions/savings/investment against NPS, GIS, PPF, Mutual Funds/SIPs, PLI, Insurances, and Income Tax is Rs.11,53,611/- and the balance of his savings bank account(s) is also decreased by Rs.3,01,638/- in this financial year from previous year's balance. Thus, a sum of Rs.25,57,619/- was therefore available with him to meet out the household expenditure of his family consisting two members of the financial year 2019-2021 (2019-20 & 2020-21).

It is also pertinent to mention here that the officer's wife is a Judicial Officer whose whose annual income is Rs.8,76,084/- & Rs.22,03,146/- for the financial year 2019-20 & 2020-21 respectively.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2017-2019 (2017-18 & 2018-19) online against Case Id : P00005932023 and the same has been processed before Hon'ble Mr. Justice Rajeev Misra, Administrative Judge, Moradabad Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2019-2021 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial year 2019-2021 (2019-20 & 2020-21) vide online dated 17.08.2023. As such, there is delay in submitting the same for which the officer has stated in his application as attachment dated 08.08.2023, that the delay in submission of the property statements caused due to Covid-19 pandemic, for which the officer seeks forgiveness in good faith for the delay.

May, therefore, if approved, property statements for the financial year 2019-2021 (2019-20 & 2020-21) of Sri Vinay Kumar Jaiswal, A.C.J.M. (Railway), Moradabad, be laid before Hon'ble Mr. Justice Rajeev Misra, Administrative Judge, Moradabad Judgeship for His Lordship's kind perusal and orders?
