May kindly see the property statement received online from Sri Surya Kant Dhar Dubey, Chief Judicial Magistrate, Chitrakoot regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2017-19 (2017-18 & 2018-19), Gross salary is Rs.26,83,712/- and total deductions/savings/investment against GIS, NPS, Income Tax, PPF, LIC, car loan and the balance of his savings bank account is also enhanced by Rs.4,69,668/- in this financial year from previous year's balance, total of which is Rs.14,78,030/-. Thus, a sum of Rs.12,05,682/- was therefore available with him to meet out the household expenditure of his family consisting two members in both of the financial years. It is pertinent to mention here that Officer's wife is working as Dy. S.P. (PPS) in U.P., having annual income of Rs.9,00,000/- from salary, as mentioned by the Officer.

In this connection, it is submitted that the Officer has submitted his property statement upto financial years 2016-17 and the same has been seen by Hon'ble Mr. Justice Ram Surat Ram (Maurya), the then Administrative Judge, Deoria Judgeship in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. He has submitted his movable and immovable property statements for the financial years 2017-19 (2017-18 & 2018-19) vide online dated 23.08.23. As such, there is delay in submitting the same from the part of the officer, for which the officer has stated (in his verbatim) that "due to outbreak of Pandemic Covid19 in India in the beginning of year 2020 and subsequent years, requisite information could not be procured/ collected for preparing the statements. Furthermore it also submitted that undersigned also got infected by Covid 19 and due to other personal and family problems, inadvertently I could not submit my property statements(impugned year 2017-2019) timely, for which I seek apology. It is also submitted that undersigned have already sent the Statements of Movable and Immovable properties held at the time of joining of service and subsequent financial years thereof vide. Deoria Judgeship letter no. 746/xv dated 16/5/2019.(Copy is herewith attached in which reasons for delay submission of property statement has also been explained/ mentioned). It is, therefore, most humbly requested to you to please, by pardoning the applicant in late forwarding this application, bring this information to the knowledge of the Hon'ble High Court. I shall be highly obliged."

May, therefore, if approved, property statements for the financial years 2017-19 (2017-18 & 2018-19) of Sri Surya Kant Dhar Dubey, Chief Judicial Magistrate, Chitrakoot be laid before Hon'ble Mr. Justice Vikram D Chauhan, Administrative Judge, Chitrakoot Judgeship for His Lordship's kind perusal and orders?
