May kindly see the online property statement received from Smt. Pratibha Narayan, Special Judge (E.C. Act), Lakhimpur Kheri regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2020-21 & 2021-22 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-21 & 2021-22 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2020-21 & 2021-22, Total income is Rs.52,23,216/- (income from salary & allowances are Rs.39,21,414/-, income from interests of Rs.5,02,118/-, Agricultural income of Rs.2,35,000/- and matured amount of policy of Rs.5,64,684/-) and total deductions/ repayment/ savings/ investments (for both the financial years) against GIS, NPS, Income Tax, PPF, Home loan and the balance of her savings bank account(s) is enhanced for Rs.7,88,025/- this financial year from previous year's balance, total of which is Rs.26,69,877/-. Thus, a sum of Rs.25,53,339/- was therefore available with her to meet out the household expenditure of her family consisting four members in both the financial years.

It is pertinent to mention here that her husband is a Professor, KGMC, Lucknow having annual income of Rs.48,55,569/- approx.

In this connection, it is submitted that the officer has already submitted her property statement upto the financial years 2006-07 & 2007-08 which had already been seen by Hon'ble Mr. Justice S.C.Chaurasia, the then Administrative Judge, Pratapgarh in the misc. file of the officer. And for the financial years 2008-10, 2010-12, 2012-14, 2014-16, 2016-18 and 2018-20, detailed online notes has been submitted on e-service ID nos.6576, 6582, 6583, 6586, 6589 and 6592 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statements of the financial years 2020-21 & 2021-22 in its next financial year i.e., 2022-23 upto March, 2023. She has submitted movable and immovable property statements of the financial years 2020-21 & 2021-22 firstly vide online dated 25.08.2023. As such, there is delay in submitting the same from the part of the officer for which she has stated (in her verbatim) that "The applicant is a female judicial officer having two little daughters. The husband of applicant is professor in KGMC Lucknow. The applicant lives alone at the work place. No family member lives together. In recent years my in-laws died due to Covid and other disease. Because of the disturbance of personal life I inadvertently, could not submit the aforesaid statements earlier. Therefore please forgive the delay in submission of the statement." mentioned in remark column of movable proforma.

May, therefore, if approved, property statements of the financial year 2020-21 & 2021-22 (2020-2022) of Smt. Pratibha Narayan, Special Judge (E.C. Act), Lakhimpur Kheri, be laid before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Lakhimpur Kheri for His Lordship's kind perusal and orders?
