May kindly see the property statement online received from Sri Anil Kumar-XII, Chief Judicial Magistrate, Mau regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2020-22 (2020-21 & 2021-22), his gross income from salary is Rs.30,84,820/- and total deductions/Savings/investments against GPF, GIS, Income Tax, Insurances and Repayment of Home Loan (included Margin Money Rs.20,25,000/-) are Rs.31,80,968/-. The balance of Rs.24,10,093/- has decreased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.20,69,343/- (from saving bank account withdrawal) was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2020-22 (2020-21 & 2021-22).

It is pertinent to mention here that officer's wife (LIC commission and private teaching) having annual income Rs.3,42,010/- for the financial year 2020-21 and Rs.3,56,800/- for financial year 2021-22 respectively.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2018-20 (2018-19 & 2019-20) against online case id-P00032162021 (old case id-5360), which had already been seen by Hon'ble Mr. Justice Saurabh Srivastava, Administrative Judge, Shrawasti at Bhinga Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements for the financial years 2020-22 (2020-21 & 2021-22) vide online dated 21.08.2023. As such, there is delay submitting the same. In this regard, officer verbatim; "Due to unfavourable medical condition of me(ankle fracture) and my wife."

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Anil Kumar-XII, Chief Judicial Magistrate, Mau be laid before Hon'ble Dr. Justice Gautam Chowdhary, Administrative Judge, Mau Judgeship for His Lordship's kind perusal and orders?
