

## **Registrar(J)(Budget)**

May kindly see the online property statements received from Sri Ajay Vikram Singh, Judge, Special Court, Anti Corruption CBI (W), Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2021-23 (2021-22 & 2022-23) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2021-23 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

1. In the financial years 2021-23 (2021-22 & 2022-23), Total gross income from salary is Rs.50,34,657/- and total deductions/Savings/investments against NPS, GIS, Income Tax, Insurances, PPF, Sukanya Samriddhi Yojna and Mutual Funds are Rs.28,58,480/-. Thus a sum of Rs.21,76,177/- was therefore available with him to meet out the household expenditure of his family consisting three members in the financial years 2021-23 (2021-22 & 2022-23). The balance of his savings bank account has also been reduced Rs.6,90,602/- from the balance of the previous year.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2019-21 (2019-20 & 2020-21) online, which had already been seen online by Hon'ble Mr. Justice Rajan Roy, the then Administrative Judge, Lucknow Judgeship.

It is pertinent to mention here that officer's wife has earned annual income of Rs.5 lakh approx. from teaching for the F.Y. 2021-22 & 2022-23 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2021-23 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. He has submitted movable and immovable property statements for the financial years 2021-23 (2021-22 & 2022-23) firstly vide online dated 20.09.2023. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2021-23 (2021-22 & 2022-23) of Sri Ajay Vikram Singh, Judge, Special Court, Anti Corruption CBI (W), Lucknow be laid before Hon'ble Mr. Justice Rajan Roy, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
