In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2021-23 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial years 2021-23 (2021-22 & 2022-23), her gross income is Rs.50,64,752/- (Rs.49,34,665/- from salary and Rs.1,30,087/- from other sources) and total deductions/Savings/investments against, Deposits in Saving Bank Account, NPS, GIS, Income Tax, PPF, FDR and Insurances are Rs.38,81,779/-. The balance of Rs.7,55,092/- has increased from her saving bank A/c's against the balance of the previous year. Thus a sum of Rs.11,82,973/- was therefore available with her to meet out the household expenditure of her family consisting two members in the financial years 2021-23 (2021-22 & 2022-23).

In this connection, it is submitted that the Officer has already submitted her property statement for the financial years 2019-21 (2019-20 & 2020-21) online against case id- P00011922021 (old case id-3293) and same has been processed before Hon'ble Mr. Justice Sameer Jain, Administrative Judge, Bhadohi at Gyanpur Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2021-23 (2021-22 & 2022-23)) in its next financial year i.e., 2023-24 upto March 2024. She had submitted movable and immovable property statements for the financial years 2021-23 (2021-22 & 2022-23) vide online dated 07.10.2023 on eServicesJo portal. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2021-23 (2021-22 & 2022-23) of Smt. Madhu Dogra, ADJ (POCSO), Bhadohi at Gyanpur be laid before Hon'ble Mr. Justice Sameer Jain, Administrative Judge, Bhadohi at Gyanpur Judgeship for His Lordship's kind perusal and orders?
