In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2021-2023 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2021-2023 (2021-22 & 2022-23), Total income is Rs.97,92,856/- (Gross income from salary is Rs.54,03,708/-, matured amount of NSC of Rs.49,164/-, redeemed amount of various SIPs/Mutual Funds of Rs. 34,98,283/- and Interest/gain on SB account, Mutual Funds, Gold Bond and other investments of Rs.8,41,701/-) and total deductions/ repayment/ savings/ investment against NPS, GIS, NSC, Income Tax, PPF, SIPs/Mutual Funds, Insurance policies, Gold Bonds and the balance of his and his wife's savings bank account(s) is enhanced for Rs.4,97,636/- this financial year from previous year's balance, total of which is Rs.87,95,821/-. Thus, a sum of Rs.9,97,035/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years.

It is pertinent to mention here that his wife have total income of Rs.87,206/- and Rs.1,21,525/- through interest/dividend/commission from SB account, Mutual Fund, Shares, LIC etc., for the financial year 2021-22 & 2022-23 respectively.

In this connection, it is submitted that the officer has already submitted his property statements of the financial years 2019-2021 (2019-20 & 2020-21) online vide Case Id: P00054352022, which has already been processed before Hon'ble The Chief Justice for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2021-2023 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. He has submitted movable and immovable property statements of the financial years 2021-2023 (2021-22 & 2022-23) vide online dated 29.08.2023. As such, there is no delay in submitting the same.
