May kindly see the property statement received online from Sri Satya Pal Singh Premi, Judge Small Causes Court, Prayagraj, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2021-2023 (2021-22 & 2022-23) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2021-2023 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2021-2023 (2021-22 & 2022-23), the Gross income from salary is Rs.37,79,205/- and total deductions/savings/investment against CPF, GIS, PPF, Loan repayments, Insurances and Income Tax is Rs.23,51,274/- and the balance of his savings bank account(s) is also increased by Rs.4,53,691/- in this financial year from previous year's balance, total of which is Rs.28,04,965/-. Thus, a sum of Rs.9,74,240/- was therefore available with him to meet out the household expenditure of his family consisting four members in the financial year 2021-22 & 2022-23.

It is pertinent to mention here that Officer's wife have annual income of Rs.6.5 Lacs approx. as Practicing Lawyer at High Court.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2019-2021 (2019-20 & 2020-21) online against Case Id : P00015222021 (Old Case Id : 3635) and the same has been processed before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Allahabad Judgeship for Her Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2021-2023 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. He has firstly submitted movable and immovable property statements of the financial year 2021-2023 (2021-22 & 2022-23) vide online dated 05.09.2023. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial year 2021-2023 (2021-22 & 2022-23) of Sri Satya Pal Singh Premi, Judge Small Causes Court, Prayagraj, be laid before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Allahabad Judgeship for Her Lordship's kind perusal and orders?
