May kindly see the online property statements received from Sri Vikash Kumar-II, Additional Principal Judge, Family Court, Deoria regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2020-21 & 2021-22 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties of the financial years 2020-21 & 2021-22 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2020-21 & 2021-22, Total Gross income from salary is Rs.42,58,255/- and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, PPF, LIC policy and FDR are Rs.64,54,828/-. And the balance of his savings bank account(s) is also reduced for Rs.26,06,033/- this financial year from previous year's balance. Thus, a sum of Rs.4,09,460/- was therefore available with him to meet out the household expenditure of his family consisting of three members in both the financial years.

It is pertinent to mention here that his wife is Judicial Officer having annual income of Rs.8,76,617/- and Rs.23,87,949/- in the financial years 2020-21 & 2021-22 respectively.

In this connection, it is submitted that he has already submitted his property statement upto the financial year 2015-16 which has already been seen by Hon'ble Mrs. Justice Vijay Lakshmi, the then Administrative Judge, Hamirpur in the misc. file of the officer. Property statement of the financial years 2016-18 & 2018-20 have been laid online before Hon'ble Mr. Justice Rajeev Singh, Administrative Judge, Deoria Judgeship for His Lordship's kind perusal and orders on e-Service IDs 5325 & 5085 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2020-21 & 2021-22 in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial year 2020-21 & 2021-22 vide online dated 19.09.2023. As such, there is delay in submitting the same from the part of the officer for which he has stated that "In Corona time mother expired and due to family problems property statement can not be submitted, He apologize", mentioned in officer's reply.

May, therefore, if approved, property statements for the financial year 2020-21 & 2021-22 of Sri Vikash Kumar-II, Additional Principal Judge, Family Court, Deoria be laid before Hon'ble Mr. Justice Rajeev Singh, Administrative Judge, Deoria Judgeship for His Lordship's kind perusal and orders?
