

**Registrar(J)(Budget)**

May kindly see the online property statement received from Smt. Chhaya Nain, Addl. District & Sessions Judge, Deoria regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2020-21 & 2021-22 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-21 & 2021-22 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2020-21 & 2021-22, Total Gross income from salary is Rs.32,64,566/- and total deductions/ repayment/ savings/ investments (for both the financial years) against GIS, NPS, Income Tax, PPF, LIC and FDR are Rs.62,42,362/-. The balance of her savings bank account(s) has been reduced for Rs.32,41,146/- this financial year from previous year's balance. Thus, a sum of Rs.2,63,350/- was therefore available with her to meet out the household expenditure of her family consisting four members in both the financial years.

It is pertinent to mention here that her husband is also a Judicial officer and having annual income of Rs.20,30,960/- and Rs.22,27,295/- in the financial years 2020-21 & 2021-22 respectively.

In this connection, it is submitted that officer has already submitted her property statement upto the financial years 2015-16 which had already been seen by Hon'ble Mrs. Justice Vijay Lakshmi, the then Administrative Judge, Hamirpur, placed in the misc. file of the officer. and of the financial years 2016-17 & 2017-18 and 2018-19 & 2019-20, detailed notes have been submitted online before Hon'ble Mr. Justice Rajeev Singh, Administrative Judge, Deoria Judgeship for His Lordship's kind perusal and orders, on eService IDs P00008842023 and 4689 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statements of the financial years 2020-21 & 2021-22 in its next financial year i.e., 2022-23 upto March 2023. She has submitted movable and immovable property statements of the financial years 2020-21 & 2021-22 firstly vide online dated 18.09.2023. As such, there is delay in submitting the same.

May, therefore, if approved, property statements of the financial years 2020-21 & 2021-22 of Smt. Chhaya Nain, Addl. District & Sessions Judge, Deoria, be laid before Hon'ble Mr. Justice Rajeev Singh, Administrative Judge, Deoria Judgeship for His Lordship's kind perusal and orders?
