May kindly see the online property statement received from Smt. Nuhin Zaidi, Judge Small Causes Court, Jhansi regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2020-21 & 2021-22 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court. In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-21 & 2021-22 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2020-21 & 2021-22, Total income from salary & interest is Rs.37,53,790/and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, PPF, RD, LIC policies and the balance of her savings bank account(s) is enhanced for Rs.16,27,655/- this financial year from previous year's balance, total of which is Rs.30,94,755/-. Thus, a sum of Rs.6,59,035/- was therefore available with her to meet out the household expenditure of her family consisting four members in both of the financial years.

It is pertinent to mention here that her husband's income is Rs.1,00,000/-, as mentioned in column no.3 of movable proforma.

In this connection, it is submitted that the officer has already submitted her property statement at the time of joining into Judicial Service which had already been seen by Hon'ble Mr. Justice Shashi Kant Gupta, the then Administrative Judge, Meerut, placed in the misc. file of the officer. Property statements of the financial years 2014-15 & 2015-16, 2016-17 & 2017-18 and 2018-19 & 2019-20 have been processed on e-service IDs 6485, 6497 and P00056432022 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statements of the financial years 2020-21 & 2021-22 in its next financial year i.e., 2022-23 upto March 2023. She has submitted movable and immovable property statements of the financial years 2020-21 & 2021-22 firstly vide online dated 22.09.2023. As such, there is delay in submitting the same from the part of the officer for which she has stated (in her verbatim) that "with Due respect I beg to say that I am very sorry for delayed submission of property statement. I have joined service on 16/02/2015. I have submitted my first property statement at the time of joining on date 10.12.2015 and subsequently on date 23.04.2016. Sir, I was new in the service so I was confused that I have sent property statement already. Due to this reason I could not submit it in time. Later on, I came to know that I have to sent the property statement regularly. I assure you,sir, that in future, I shall keep my self vigilant in this regard. Again, I am very sorry for delay and beg pardon to Hon'ble Court for delay", mentioned in remark column of movable proforma.

May, therefore, if approved, property statements of the financial years 2020-21 & 2021-22 of Smt. Nuhin Zaidi, Judge Small Causes Court, Jhansi be laid before Hon'ble Mr. Justice Manish Mathur, Administrative Judge, Jhansi Judgeship for His Lordship's kind perusal and orders?
